

# Ticket system

You will receive a certain contingent of tickets for your customers and employees, you can allocate these according to the criteria listed below. Additionally required tickets can be purchased.

## CORPORATE TICKET | EUR 1.400 „full day“

**Employees from the treasury or finance departments of companies.**

As a provider (sponsor, exhibitor, workshop provider, etc.), you will receive a certain contingent of corporate tickets with which you can invite your customers to the Finance Symposium.

### More information about the Corporate Ticket

- » Tickets purchased through the service packages are valid for the entire three days of the event.
- » There are NO additional costs as long as you do not exceed your quota.
- » Up to 3 people from one company can participate in the event via a customer ticket. However, only ONE person per day!
- » Customer tickets can NOT be converted into employee tickets!

## EMPLOYEE TICKET | CONTRACTUALLY AGREED

**You will receive a contractually agreed contingent of employee tickets including participation in the official gala evening on Thursday, which you can allocate as you wish.**

### More information about the employee ticket

- » The event is divided into four half-days (Wednesday, Thursday morning and afternoon, Friday).
- » Unlike the customer tickets, here you can freely choose when and how to divide the employees among the four half-days
- » If more internal employees want to participate in the event than are included in the contingent, you can buy them at the price and conditions of the „non-corporate tickets
- » A subsequently purchased employee ticket does not automatically entitle the holder to attend the gala evening on Thursday.
- » If you do not use up all of the employee tickets you purchased in the package, you will not be refunded.

## NON-CORPORATE TICKET | EUR 2.880 „ENTIRE EVENT“ (EXCLUSIVE GALA EVENING)

**Employees from the sales, product development, consulting, etc. departments of banks, financial services companies, system or information providers, as well as auditors, tax consultants or management consultants. Furthermore, all employees of exhibitors, outside the contractually agreed ticket contingent, belong to the category of non-corporates..**

### Further information on the Non-Corporate Ticket

- » The purchase of a non-corporate ticket takes place at the advertised daily rates.
- » Up to four people from one company can participate in the event via the full event ticket.
- » The purchase of a non-corporate ticket does not automatically entitle the holder to attend the official gala evening on Thursday. However, they can be purchased at the advertised price.
- » Non-corporates from non-exhibitors must book the entire Thursday to purchase a Gala ticket.

## SPEAKER TICKET | FREE OF CHARGE

**Contracted speaker tickets apply exclusively to a provider's internal speakers.**

Customer representatives from the treasury or finance departments of companies can attend the event free of charge and including the official gala evening.

### **More information about the speaker ticket**

- » The speaker ticket is valid only for the day of the lecture.
- » The speaker ticket does not automatically entitle the holder to attend the gala evening on Thursday. A subsequent purchase at the price of EUR 450 is possible at any time.
- » External speakers, who fall under the category Non-Corporate are chargeable at the daily rate for Non-Corporates.
